Dear Valued Customer,

Please send in your agreement now, **even if you have been a customer for many years**. This will enable us to plan for the upcoming heating oil season. Your agreement must be returned by **August 30, 2018** so we can calculate your budget payments.

Thank you for choosing JW Perkins for your heating fuel needs. Keep us in mind for all of your fuel and lubrication requirements!

HEATING OIL AGREEMENT 2018-2019 SEASON

Offer & Duration: We offer to supply your entire premium heating oil requirements at the address shown on this acceptance during the period that this agreement is in effect beginning **September 1st, 2018 through June 10th, 2019**.

Terms: 10th of the month. All home heating oil invoices or budget payments are due on the 10th of each month. Failure to meet agreed upon terms including any missed budget payments will result in a delay of any additional deliveries and a 1-1/2% per month service charge applied to the balance owed. Failure to pay any incurred service charges shall result in a delay of deliveries.

Budget Payments: Budget payments are calculated on your prior 3 year consumption and an estimate of the cost of fuel for the heating oil season. JW Perkins may need to adjust the budget amount during the season if there is a significant change to your usage or in the cost of fuel during the contracted season.

Quality: Seller guarantees that all products delivered will meet all government specifications.

Delivery: Seller will make deliveries with all possible promptness after receipt of orders. All **Will Call** customers require a minimum **3 day** lead time. Emergency deliveries will be charged a fee of \$50.00. All **Will Call** customers receiving a delivery of less than 150 gallons will be charged a fee of \$50.00.

Seller shall not be responsible for failure to make any deliveries when conditions, in our opinion, are beyond our control (weather, road construction, accidents, etc.) All automatic delivery accounts are estimated and JW Perkins cannot guarantee that the customer will not run out of fuel.

JW Perkins is unable to make deliveries where driveways are not accessible (snow plowed, free of debris, etc.). Customers requesting our trucks to go off of a driveway will be responsible for any tow truck fees and a minimum hourly fee of \$70.00 per hour for lost truck/driver time.

Seller shall be liable for damages to the premises at the time of delivery where such damage is caused by negligence on our part. It is understood that the above constitutes the entire agreement between the parties, here to, and that no other terms or conditions expressed or implied, are effective.

Billing Option: Please check if you would like to be on the budget plan

- ☐ Budget Plan: 9 equal monthly payments beginning September 10th, 2018 thru May 10th, 2019 with the final balance due to be paid in full **June 10th, 2019**. IF budget payments or the final balance are not paid on time, the account will revert to terms with full payment due on the 10th of month, and you will not qualify for the budget plan for the following year.
