- Earned Income Tax Credit
 - Must have Earned income
 - Retirement/investment/social security/alimony./ child support do not count as earned income.
 - \circ 4 tests that the dependent must meet to qualify for the credit
 - Relationship
 - Must be son daughter, etc
 - Age
 - Child must be under the age of 19 or full time student under 26,or be totally and permanently disabled regardless of age
 - Residency
 - Must live with taxpayer for more than half the year
 - Joint return
 - The child cannot file a joint return for the year.
 - Proof needed for credit one of the following
 - School records or statement
 - Landlord or property management statement
 - Health care provider records
 - Child care provider records
 - Social services records or statement
 - Indian Tribal statement
 - Statement from place or worship
 - Disability Proof
 - Doctor Statement
 - Social Services agency or program statement
