WE WILL CALCULATE THE EXTRA AMOUNT OF HOURS AND CHARGES WHEN THE TRIP IS COMPLETED. WE WILL THEN DEDUCT YOUR DEPOSIT AMOUNT LEAVING THE ACTUAL BALANCE DUE. CLIENT AUTHORIZES CHARGES TO CREDIT CARD, WITH/WITHOUT IMPRINT. **CONTRACT NEEDS TO BE PAID IN FULL 30 DAYS BEFORE THE CONTRACT DATE UNLESS OTHERWISE AGREED ON FIRST PAGE.**

LIMOUSINE RULES AND REGULATIONS:

NO ALCOHOL CONSUMED BY ANYONE LESS THAN 21 YEARS OF AGE. VIOLATION MAY RESULT IN EARLY TERMINATION, NO REFUNDS.

NO SMOKING INSIDE LIMOUSINE IF THERE IS AN ACCIDENT LIKE A SEAT BURNED \$500.-DLLS WILL CHARGED, NO EXCEPTIONS. (NO SMOKING ALLOWED INSIDE LIMOUSINE, A FINE OF \$500.-DLLS)

CLEAN-UP FOR VOMITING IN THE LOMOUSINE WILL BE ASSESSED. ALL TOLLS AND PARKING FEES ARE NOT INCLUDED IN RENTAL RATE.

SOMETIMES HEAT AND EXCESSIVE USE OF ALL POWER-OPERETED EQUIPMENT MIGHT BE SUBJECT TO TEMPORARY FAILURE. WE HAVE THE RIGHT TO REPLACE THE LIMOUSINE IF AVAILABLE AT THE SAME TIME OF CONTRACT IF THERE IS NOT EQUIPMENT (LIMOS) AVAILABLE WE WILL REPLACE THE LOSS OF TIME OR CONTRACT WITH THE SAME HOURS IN THE CONTRACT AT ANOTHER DATE AND TIME AVAILABLE. WE WILL NOT REFUND MONEY FOR ANY OF THE FOLLOWING REASONS: WEATHER CONDITIONS, EXCESSIVE HEAT, EMERGENCY BREAKDOWN, EMERGENCY MECHANICAL PROBLEMS OR ANY OTHER PROBLEMS CAUSED BY MATTERS THAT ARE OUT OF OUR CONTROL. WE WILL USE OUR BEST EFFORTS TO NOTIFY OUR CUSTOMER OF THIS CONDITIONS AND RESULTING OF DELAYS OR CHANGES ON THE CONTRACT, ALL OVER THE VALLEY LIMO RESERVES THE RIGHT TO OFFER YOU TO RE-SCHELUDE THE CONTRACT TO ANOTHER TIME AND DAY REPLACE THE SERVICE ON THE CONTRACT.

ALL OVER THE VALLEY LIMO WILL NOT BE RESPONSIBLE FOR ANY DELAYS OR INCONVENIENCES DUE TO TRAFFIC, UNFORESCEN MECHANICAL FAILURES, OR SITUATIONS DEENED AN "ACT OF GOD". CUSTOMER MUST PROVIDE DIRECTIONS FOR PICKUPS AND DROPOFFS NO EXCEPTIONS DRIVERS MAY GET LOST DUE TO MISSING STREET SIGNS ETC.

2. EXCESSIVE CHANGING OF RADIO IS NOT ALLOWED CHANGING OF STROBE LIGHTS AND PLAYING WITH ELECTRONIC NO ONE IS ALLOWED TO STAND ON SEATS OR STICK HEADS OUT OF OR OPEN SUN ROOF. HEADS ARE NOT TO BE STUCK OUT OF SIDE WINDOWS.
3. CHANGE OF SCHEDULE WILL BE BILLED FOR THE AMOUNT OF \$50 PAID IN ADVANCE.
4. ALL UNRULY PERSONS WILL BE DROPPED OF AT THE SOLE DISCRETION OF THE DRIVER & NO REFUNDS.
5. WE WILL NOT BE RESPONSIBLE FOR ANY LOST, DAMAGED OR STOLEN PROPERTY.
6. NO ILLEGAL DRUGS ARE PERMITTED IN ANY LIMOUSINE EVER.
7. OVERTIME WIL BE BILLED IN HOUR INCREMENTS. WHICH MEANS YOU GO OVER 10 MINS YOU PAY \$100 SMALL OR \$200 LARGE.
8. CUSTOMER AGREES THAT OVERTIME WILL BE BILLED AT THE CONTRACTED RATE AND AGREES TO PAY OVER CHARGES.
9. CUSTOMER AGREES THAT REPLACEMENT LIMOUSINE MAY BE SUBSTITUTED IN THE EVENT OF ANY MAYOR MECHANICAL ISSUES, ETC.
10. ALL ENTERTAINMENT INCLUDING CDS, DVDS IS TO BE PROVIDED BY THE CUSTOMER.
11. CUSTOMERS INSIDE LIMOUSINE AND ONCE LIMOUSINE IS ON MOVEMENT MUST REMAIN SEATED, (ALL OVER THE VALLEY LIMO) IS NOT RESPONSIBLE FOR ANY ACCIDENTS THAT MAY OCCUR TO PERSONS INSIDE THE LIMOUSINE DURING CONTRACT HOURS.
12. CUSTOMERS MUST WAIT FOR DRIVER TO OPEN THE DOORS OF THE LIMOUSINE IN ORDER TO ENTER OR EXIT THE LIMOUSINE IN ORDER TO PREVENT FALLS OR ACCIDENTS.
13. CHEWING GUM, FROSTING, GLITTER OR RICE IS NOT PERMITTED IN ANY CHARTER AT ANY TIME. (SUNROOFS ARE NOT TO BE OPENED EVER. ESPECIALLY BY CHILDREN.
14. DRIVERS MAY REFUSE OR TEMINATE THE CHARTER AT ANY TIME WITHOUT REFUND IF THEY DEEM THE PARTY UNRULY OR ENDANGERING THE SAFE USE OF THE VEHICLE.
15. ALL OVER THE VALLEY LIMO HAS ZERO TOLERANCE FOR ANY ILLEGAL ACTS DURING RENTAL.
