Wellness Membership Plan Agreement and Payment Authorization

This wellness plan agreement is between the above named member and Body Works Massage Clinic. Body Works Massage Clinic agrees to provide the member with one 50-minute massage per month for \$60 beginning on the date of this agreement. Any additional massages purchased during the month may be purchased at a price of \$55. Fees: The plan agreement continues a month-to-month basis until cancelled. This agreement may be cancelled only as indicated below. With the inception of this agreement, the member has paid \$25.00 membership fee and the first month's dues of \$60 which will be used towards your massage. These and any subsequent dues paid are nonrefundable regardless of the fact that the member may or may not have taken advantage of membership benefits. Electronic Payments: Monthly dues must be made via automatic charge to the member's debit or credit card. The member hereby authorizes Body Works Massage Clinic to charge the debit/credit card listed above for all scheduled dues payments and any other fees accrued per this agreement on the dates indicated in this agreement. Member is responsible for ensuring that Body Works Massage Clinic has accurate account information. Late Fees and Other Charges: Should any automatic payment be declined or returned for any reason, Body Works Massage Clinic may automatically charge the member's account the amount of payment plus a \$10.00 return item fee within 15 days of the decline. Body Works Massage Clinic, at its option, may attempt to charge the member's account the amount of the overdue payment plus accrued return item and late fees along with the next scheduled payment or cancel this agreement. If the agreement is cancelled, the member may accrue additional fees. See "Cancellation" below. Option to Put On-Hold with Your Monthly Recurring Payment: Shall there be any financial circumstances and you decide to stop the recurring monthly payment, BWMC gives you the flexibility to freeze your account. Cancellation: In order to cancel this agreement, the member must provide Body Works Massage Clinic written notice at least 30 days prior to the due date of the next scheduled dues payment. Under no circumstances shall amounts previously paid be refunded. Once cancelled, this membership may not be reinstated. A new membership agreement will need to be made by former members to rejoin. Note that memberships cancelled due to non-payment of dues shall be subject to this provision as well. Member agrees to pay reasonable collection costs including attorney's fees if amounts remain due under this contract more than 30 days after cancellation.
