This letter is provided to explain the general procedures of a divorce case.

There are two types of divorce:

- A. **NO FAULT**: (Irreconcilable differences) Both Parties must sign and all pleadings must be completed prior to filing. No service is required.
- B. **FAULT**: Traditional served Complaint which sets forth both fault and no-fault grounds. Service includes by deputy, publication, registered mail or Secretary of State. Can be converted to no-fault divorce if spouse later wishes to sign pleadings.

Various mandatory "cooling off periods" will be involved in your divorce – 60 days without children or 90 days with children, starting on the date the Complaint is filed. Failure to obtain service or a waiver of service because your spouse didn't sign no-fault pleadings, will extend the time required to obtain your divorce. In fault divorces you additionally have to default your spouse for not answering which may involve an additional six weeks delay. A no-problem, uncontested divorce without children takes about four months at a minimum, and with children, about five months at a minimum.

If you were quoted a Set Fee for an uncontested fault or no-fault divorce, you are entitled to the following services: initial conference; preparation of the Divorce Complaint; preparation of a Default Judgment; preparation of the Final Decree of Divorce; and a short Court hearing to obtain the divorce. A second set of final pleadings or revisions to the first set not due to our mistake are subject to a \$100.00 charge. In Set Fee divorces, you are entitled to a reasonable amount of calls or emails (3 – 4 total while the divorce is pending). Excessive phone calls, emails or responses required thereto from the Attorney are subject to a charge of \$25.00 each.

CONTESTED DIVORCES occur if your spouse hires an attorney or merely files a handwritten letter with the Clerk's office. If contested and you can't work out the

details of your divorce, mandatory mediation is then required. You split the Mediator's fee with your spouse and my attendance is optional, but costs extra, (pre-paid), if requested. Expect a contested divorce to at least triple the cost of your Set Fee divorce.

If you wish to add material to your file it needs to arrive at my office in a form ready to place in your file, such as regular mail, copies, fax or email. When sending emails, please confirm with my staff that we have received your email.

Once the appropriate time periods have passed and the fee has been paid in full, the divorce will automatically be set and you will be sent a letter informing you of the trial date, court location, and the exact time to be present. If you have a fault divorce and fail to bring a witness, your divorce will be delayed. If you have prepaid the Clerk's filing fee, you may still be billed directly from the Clerk's Office upon completion of the divorce for some small amount of the remaining court costs.

**If you are currently pregnant, become pregnant while the divorce is pending or
have had a child during the marriage by another man, expect your divorce to
be delayed a significant amount of time until a live birth takes place or until the
child born subsequent to the separation is paternity tested. Some Judges will
appoint a Guardian Ad Litem to make a report to the Court (at your expense).**
