The principal and surety agree that in the event the principal is not a United States citizen and is taken into custody by the United States Department of Homeland Security Immigration and Customs Enforcement (“ICE”), and fails to make his personal appearance in Court, that the principal and surety shall remain jointly and severally liable on the bond and agree to waive the statutory defenses set forth in articles 17.16 (a) (2) and 22.13 (a) (3) of the Texas Code of Criminal Procedure.

This bond shall also be conditioned that the principal and sureties, if any, will pay all necessary and reasonable expenses incurred by any and all sheriffs or other peace officers in re-arresting the principal in the event he fails to appear before the Court or Magistrate named in this bond at the time stated herein. The amount of such expense shall be in addition to the principal amount specified in this bond.
