This agreement outlines the terms of your dog's stay. The dog's Owner and Camp K9 Paradise for Paws, LLC (hereafter "Camp K9") agree to the following:

1. The Owner hereby certifies to the accuracy of all information given about the dog. The Owner specifically represents that the dog has not been exposed to rabies or distemper and has not been ill with any communicable condition within a 30-day period prior to the receipt of services. Also, that the dog is in good health and is current on required vaccinations.
2. The Owner represents that his/her dog has not bitten or shown any aggressive or threatening behavior toward any person, child or animal, except as described below:

3. The Owner certifies that if the dog will be participating in any group activities, such as day care, group play and training, that the dog is neutered or spayed if over the age of six months.
4. The Owner understands that he/she is solely responsible for any harm caused by his/her dog to any person, other pets or property at Camp K9.
5. The Owner understands and agrees that in admitting his/her dog to participate in activities, Camp K9 staff have relied on the representation set forth herein.

6. The Owner understands that dogs, when in groups, can accidentally injure each other while playing. Minor cuts, scrapes, bite wounds and bruises are a possible, and not unexpected, result of participation in group activities. The Owner understands and agrees that Camp K9, its staff, agents and assigns shall not be liable for any problems that develop, provided reasonable care and precautions are followed. The Owner hereby releases them from any liability of any kind arising from his/her dog's participation in day care, boarding, training or any other dog services provided by Camp K9.
7. The Owner agrees to pay all costs and charges for special services requested, including, but not limited to, individual or group play and veterinary visits. If a dog is found to have fleas and/or ticks, it will be bathed at the Owner's expense.
8. If the dog becomes ill, or if the state of the animal's health otherwise requires professional attention, Camp K9, in its sole discretion, may engage in the services of a veterinarian or administer medicine or give other requisite care to the dog, and the expense thereof shall be paid by the Owner.
9. Camp K9 shall exercise reasonable care for the dog delivered by the Owner to Camp K9 for any services. It is agreed by the Owner that Camp K9's liability shall in no event exceed the lesser of the current chattel value of a dog of the same species, or the sum of \$500.00 per animal brought to Camp K9.
10. Camp K9 will make every effort to return items left with the dog. However, these items may not be returned or they may be returned in poor condition. Camp K9 is not responsible for these items.
11. Bathing - all guests of Camp K9, if their stay is longer than 3 days, may receive a basic bath at the Owner's expense as deemed necessary by Camp K9 staff.
12. Grooming - any grooming which takes place on an elderly animal or animal with health problems will be at Owner's risk. Grooming may expose pre-existing health/skin problems for which Camp K9 cannot be held liable. De-matting/thinning out of matted hair may cause patchiness and hair loss. Consent to remove the matted hair is on this understanding.
13. All charges incurred by Owner shall be payable upon date scheduled for pick-up of the dog. The dog will not leave Camp K9 until all charges are paid by the Owner.
14. The Owner agrees to abide by Camp K9's policies regarding hours of operation, cancellation fees, vaccinations requirements and other operational and safety regulations.
15. The Owner gives permission for publication of photos or video taken of the dog and/or Owner by Camp K9. The Owner understands that the Owner will not be paid any royalty or other compensation and hereby relinquishes any and all rights for payment if a photo or video of the dog and/or Owner is published in any form or medium.
16. If Camp K9 determines that the dog requires special handling, Camp K9 reserves the right to charge the Owner a \$10 special handling fee.
17. This agreement contains the entire agreement between parties. All terms and conditions of this agreement shall be binding on the representatives and assigns of the Owner and Camp K9. This contract shall remain in effect for subsequent transactions between the Owner and Camp K9.
